

#### SGM Jack Nevils - SF Ret.

Mr. Nevils served 25 years in active military service, two years as an Airborne Ranger in the 1st Ranger Battalion, then 23 years in the Special Forces (Green Berets), serving in a variety of assignments in 7th and 3rd Special Forces Groups and the JFK Special Warfare Center and Schools.



Mr. Nevils retired in early 2013 as a Sergeant Major, the highest enlisted rank in the U.S. Army. During his career, he worked in numerous countries in South and Central America conducting Counter-Narcotics and Foreign Internal Defense missions. Mr. Nevils trained foreign Tier 1 hostage rescue units (Military and Police) in Close Quarters Combat, sniper operations, integrated assaults, and Military Free Fall operations (HALO). Mr. Nevils also trained allied Police Units in Personnel Security Details (PSD) for high level government officials.

Since the Global War on Terrorism, Mr. Nevils has deployed numerous times to the Middle East, Central Asia, and Africa including combat action in Operation ENDURING FREEDOM and Operation IRAQI FREEDOM. He trained, advised, and led the Iraqi Counter Terrorism Force on hundreds of urban counter terrorist's operations throughout the country of Iraq in support of national objectives resulting in hundreds of enemy combatants removed from the battlefield. Mr. Nevils conducted a wide range of Special Operations activities in progressively greater roles of responsibility including: targeting in support of national objectives, human intelligence operations (HUMINT), unilateral direct action, and counter terrorism operations by, with, and thru indigenous forces.

Mr. Nevils was the Senior Trainer and Program Manager (NCOIC and Sergeant Major) for the Special Forces Hostage Rescue and Sniper Schools at Ft. Bragg, NC. During this time, he used his combat experiences to rewrite the Programs of Instruction and training methodologies for Close Quarters Combat including: combat marksmanship, single and multi-team operations, explosive, ballistic, and mechanical breaching, sniper integrated assaults, urban sniper operations, vehicle interdiction, vertical and linear assaults, and personnel handling (Combatives) to meet the emerging threats of today's unconventional battlefield. Mr. Nevils has also developed curriculum for and taught integrated fighting personal protection courses for High Value Individuals and Government overseas singleton operators.

His military awards include the Purple Heart, Legion of Merit, Bronze Star with Valor, Bronze Star, Meritorious Service Medal with three oak leaf clusters, the Combat Infantry Badge, Expert Infantry Badge, Master Parachutist Badge, Master Freefall Badge, Special Forces Tab and the Ranger Tab.

#### SSGT VANGUARD LEVE ONE

The SSGT Vanguard Level One Instructor and Student Courses are broken down into seven (7) Categories as follows:

- **1.Common Grab Defense** against wrist grabs, throat grabs, hairgrabs and lapel grabs in a standing position.
- **2.Headlock Defense** against a rear headlock, front headlock and side headlocks both standing & on the ground.
- **3.Bear-hug Defense** against front over and under the arms and rear over and under the arms.
- 4.Tackle Defense against double leg and single leg tackles.
- **5.Striking & Knife Defense** against various strikes and cutting instruments.
- **6.Escaping From The Bottom (ground)** escapes from the mounted position and side positions.
- 7. Controlling A Grounded Subject From The Top -

various controlling techniques designed to enable the officer to place the subject into a position for handcuffing.

Instructors are not required to teach all Level One Categories to their students. Instructors may certify students in certain categories and omit others.

#### SSGT VANGUARD LEVEL TWO

The SSGT Vanguard Level Two Instructor and Student Courses are broken down into thirteen (13) categories as follows:

- **1.Strategic Subject Escort –** escorting an unrestrained subject and taking the subject down to the ground upon resistance.
- 2.Pressure Points to Escort applying pressure points in an objectively reasonable manner for the purpose of subject control and compliance. Vehicle Extraction hands-on techniqes for removing a subject from a vehicle.
- 3.Strategic Handcuffing & Transport deploying and applying handcuffs to a subject in the standing, kneeling and prone positions. Also, the safe and proper transport procedure of a restrained subject.
- 4.Strategic Frisk & Search the safe and proper procedures for frisking and searching a subject.
- **5.Strategic Striking** the use of personal weapon strikes to prevent or stop aggressive action in an objectively reasonable manner.
- 6.Holstered Handgun Retention while Standing against one- and two-handed attacks on the officers handgun from the front and rear.
- **7.Holstered Handgun Retention while on the Ground** against one- and two-handed attacks on the officers handgun when the officer is on the ground.
- **8.Drawn Handgun Retention while Standing** against one- and two-handed attacks on the officers handgun in standing situations.
- **9.Drawn Handgun Retention while on the Ground** from the mounted position and side positions.
- **10.Long Gun Retention** defending against attacks on an officer's rifle, shotgun or sub-gun.
- **11.Long Gun Disarming** front and rear attacks.
- **12.Handgun Disarming** front and rear attacks.
- **13.Strategic Baton** the use of a straight or expandable baton in an objectively reasonable manner for the purpose of subject control and compliance.

Instructors are not required to teach all Level Two Categories to their students. Instructors may certify students in certain categories and omit others.

#### SSGT EDGED WEAPON SURVIVAL

The SSGT Edged Weapon Survival Program addresses the defensive and justifiable use of an edged weapon by a law enforcement officer in the line of duty. Almost every law enforcement officer in America carries a knife yet a very small percentage of those officers have any legitimate training on how to use a knife to save their own lives. And most departments have no knife policy.

This program also addresses practical and simple hands-on knife defense skills. Our techniques focus on deflecting the attack, moving and drawing the handgun. We find this to be the simplest answer to a very complex situation.

This program also educates the officers about fixed blade and folding knives, opening mechanisms, locking mechanisms, blade profiles, knife grinds, carry methods, drawing, handling and much more.

This is not a "knife fighting" course. It's designed for law enforcement.



## EQUALIZER WOMEN'S SELF-DEFENSE INSTRUCTOR

The Equalizer Women's Self-defense Program (EWSP) is a division of SSGT. This program educates women about how to recognize and reduce their risk of being victimized by violent crime and property crime and



how to defend against, survive and escape a physical attack. Many of the self-defense techniques of the EWSP are derived from our highly successful SSGT Vanguard Program. The techniques of SSGT are currently being taught to thousands of officers in various states and have been responsible for saving officers from severe injury and death in the line of duty. Our techniques have been proven to work when it counts.

#### The EWSP Student Course

The EWSP Student Course, corresponding with the EWSP handbook is for women, and teen girls. The handbook is divided into three chapters Personal Safety; Residential Security and Self-defense. The first two chapters may be covered in four hours. The third chapter, Self-defense, is divided into four phases. Each phase is four hours in length. A certificate of completions may be given to participants successfully completing any portion of the program. Students must pass the openbook written exam to be eligible to receive a Certificate of Completion from their EWSP Instructor. These courses are taught primarily by law enforcement officers who have been certified as EWSP Instructors. Check with your local law enforcement agency to see if they have an EWSP Instructor on staff. If they do not, recommend that they get one.

#### **The EWSP Instructor Course**

This course prepares law enforcement, corrections, security and education professionals to teach the EWSP to women in their communities. This course requires eight (8) hours of training for Certified SSGT Vanguard Level Two Instructors and 40 hours of training for those who are not SSGT Instructors.

When it comes to safety and security, education is the first and most important step. The goal of an EWSP Instructor is to give women the critical personal safety, residential security and self-defense information and training they need to avoid, survive and escape dangerous situations. We believe every woman should be "Prepared In Advance".

#### **EWSP CURRICULUM**

The Equalizer Women's Self-defense Program (EWSP) is divided into three chapters: Personal Safety; Residential Security and Physical Self-defense.

The first two chapters may be covered in four hours. The third chapter, Physical Self-defense, is divided into four phases. Each phase is four hours in length. A certificate of completions may be given to participants successfully completing any portion of the program. Students must pass the open-book written exam to be eligible to receive a Certificate of Completion from their EWSP Instructor.

### THE EQUALIZER & THE SCHOOL RESOURCE OFFICER

Young women should ideally be educated in personal safety, residential security, and self-defense at a young age. School Resource Officers (SROs) are well-positioned to provide

this education. High school girls preparing for college can benefit greatly from the information and training EWSP Instructors can provide. SROs are encouraged to become Equalizer Instructors to help young women be "Prepared In Advance."

Students who participate in Chapter Three: Physical Self-defense may opt-in and/or opt-out of the phases of their choice. This choice may be made based on an individual's physical limitations or training time constraints. Phase One of the program is the least physically demanding phase whereas Phase Four is the most physically demanding. This structure allows instructors to provide some level of training to almost everyone.

Every year, millions of women are victims of violence, usually at the hands of someone they know. Every woman should know how to recognize and reduce her risk of becoming a victim and how to effectively resist a physical attack, if necessary. Every woman should be "Prepared in Advance".

- Malfunctions and Immediate Action Drills for handguns / Recoil Management

- Instructor development, coaching, and diagnosing shooter errors.
- ·Critical Task Evaluations (CTE).
- Overhand, Underhand, Transition and Retention grips, Grounded Firing / 360


# TACTICAL TEAM OPS
